Card Effects【Swift】	What kind of effect is [Swift]?	Spirit cards with the [Swift] effect may be summoned from your hand during flash windows. However, when using this effect, cores used to pay summoning costs and cores placed onto the summoned spirits must come from your reserve.
Card Effects [Gale]	What kind of effect is 【Gale】?	When your attacking spirit with [Gale] is blocked by an opponent's spirit, your opponent selects the specified number of refreshed spirits they control and exhausts them.
Card Effects【Gale】	Where is the specified number written?	In the [Gale:1] keyword effect, the specified number follows the colon. In this instance, one spirit is indicated.
Card Effects【Gale】	Does [Armor: Green] protect against the [Gale] effect?	Yes, it does. Spirits with 【Armor: Green】 cannot be selected to be exhausted.
